The RSU is vested as to 0 shares on July 1, 2016.
- Grant of July 1, 2016 to reporting person of stock options under the Amended and Restated Ionis Pharmaceuticals, Inc. 2002 Non-Employee Directors' Stock Option Plan. The option vests and becomes exercisable in four equal annual installments, the first installment vesting on July 1, 2017. The option shall be fully vested and exercisable on July 1, 2020. The option is exercisable as to 0 shares on July 1, 2016.
